



FOOD SAFETY CERTIFICATION (FSC) PROGRAM

Effective July 1, 2007, California Retail Food Code requires, "Food facilities that prepare, handle, or serve un-prepackaged potentially hazardous food, except temporary food facilities, shall have an owner or employee who has successfully passed an approved and accredited food safety certification examination. There shall be at least one food safety certified owner or employee at each food facility." Certification is good for (5) years.
